**Agreement and acknowledgement**

You, the Customer:

1. Acknowledge receipt of a copy of the Credit Account Agreement and upon written notice from Pinnacle Logistics Ltd stating that credit facilities have been given, agree to observe and be bound by its terms;
2. Acknowledge receipt of a copy of Pinnacle Logistics Ltd Terms and Conditions (June 2021).
3. Are authorised to sign this document on your business' behalf;
4. Acknowledge that any information supplied by you to Pinnacle Logistics Ltd may be used for the purposes of assessing your credit application, administering your account and marketing services supplied by Pinnacle Logistics Ltd; and
5. Irrevocably authorise Pinnacle Logistics Ltd too:
  - a. Use the information for the above purposes;
  - b. Provide to any third party any information provided by you and details of any dealings Pinnacle Logistics Ltd has with you;
  - c. Obtain any information concerning you from any other source.

You are entitled to have access to this information and to correct it where necessary.

**Credit account agreement**

You, the Customer:

1. Warrant that the information in Sections A & B of the application for Credit is true and correct.
2. You agree that you are not entitled to any credit facilities until you receive notice in writing from Pinnacle Logistics Ltd stating that credit facilities have been given. Until you receive that notice, any services rendered by Pinnacle Logistics Ltd to you shall be on the basis of cash upon delivery unless other-wise agreed in writing.
3. In the event of Pinnacle Logistics Ltd granting credit facilities to you, the following terms shall apply:
  - a. All accounts are to be settled in full no later than the 20th day of the month following the date of the invoice, but in the case of disbursement invoices, such invoices shall be paid in full before delivery is made upon request by Pinnacle Logistics Ltd . A disbursement invoice means an invoice including NZ Customs Duty and/or Goods and Services Tax.
  - b. If you default in the payment of any monies due under this Agreement then all monies due to Pinnacle Logistics Ltd shall immediately become due and payable and shall be paid by you within SEVEN (7) days of the date of demand and Pinnacle Logistics Ltd shall be entitled to charge interest at 7.25 percent per month on all overdue accounts from the date of due payment until the date of actual payment.
  - c. Any expenses, costs or disbursements incurred by Pinnacle Logistics Ltd in recovering any outstanding monies including debt collection agency fees and legal fees, shall be recoverable from you.
4. Pinnacle Logistics Ltd shall be entitled without notice to terminate any credit arrangement with you in the event of your defaulting under any of the terms contained in this Agreement and in Pinnacle Logistics Ltd Terms and Conditions (June 2021).
5. The Customer is responsible for arranging insurance for transportation, loss of profit and /or consequential loss and will not off set any claim against monies due.
